Launched in 2003 by Infinite Spirits, Inc., SHAKERS Vodka is an ultra premium American spirit and brand.

SHAKERS won rave accolades, scoring a perfect 100 Score from Wine Enthusiast, a first for a vodka, along with double gold medals and Best of Show from the San Francisco Spirit Competition. Unique to SHAKERS is its patented extractive distillation process, custom filtration and premium grain raw materials. In 2009, SHAKERS generated more than 1.6 billion impressions via social media, local events and radio. Created by the founders of Pete's Wicked Ale, a craft brewing phenomena, SHAKERS Vodka offers solid and unique product lines for a new owner.

Notwithstanding SHAKERS being an exceptional product, Infinite Spirits Inc., its parent company, filed a Chapter 7 Bankruptcy petition in January, 2012. The SHAKERS brand will be sold along with the bottling equipment. SHAKERS Brand includes: recipes and processes, patents for the bottle design and distillation process, trademarks for penguin and SHAKERS name. The Bottling Line and Surplus Equipment will be sold in bulk as 39 lots.

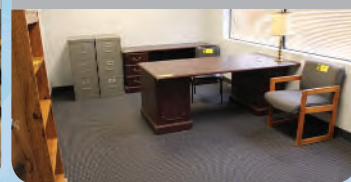
