

SunPower Biodiesel was an integrated agriculture-energy company marketing renewable fuel products. The facility was capable of utilizing virgin vegetable oil from planted crops, used vegetable oil (UVO), and fats, oils and greases (FOG) to produce biodiesel. It primarily processed canola oil because of its superior cold flow properties.

The facility produced 3 million gallons of B100 biodiesel fuel annually.
