PROJECT OVERVIEW:

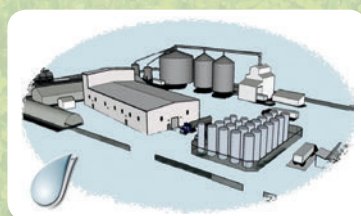
